## **Our recent achievements**

#### **Neighbourhood Planning**

The Neighbourhood Plans for Griffith and Narrabundah are now complete. Although our pleas for no higher density housing areas (A10 Core Residential Areas) in our suburbs were largely ignored, we did make considerable efforts to prevent further expansion of these areas and to protect the character of most of the older residential areas. The Griffith Neighbourhood Plan contains many references to the protection of the existing character and streetscape that the community values so highly.

We were also successful in preventing further commercial development behind the Griffith shops into Throsby Park. Attempts by the planners to dramatically expand the commercial area of the Griffith shops into Throsby Park were thwarted. The area behind the shops will be retained as "Community Facility Land".

### **Draft Variation No.165 - Open Space Network Project, July 2004**

Our Association made considerable progress over the past year to ensure that our central Open Spaces on Section 78 Griffith are protected for future generations of residents. Section 78 is the area that the old Infants and Primary Schools occupied, including their playing fields. The ACT Government recognised the importance of our open areas by including Section 78 in the Open Space Network Project Draft Variation.

#### **Community Facilities**

Our Association has made numerous representations to Government to have the old O'Connell Centre and the Griffith Library sites protected as Community Facilities. (More over)

## **Key community issues**

Although much ground has been made since the inception of the Association, there are still local issues that require resolution.

## • O'Connell Education Centre – Nursing Home and/or Aged Person's Units?

The Department of Education vacated the O'Connell Education Centre buildings in April 2004. The current temporary occupant is ACT Property, a branch of the Department of Urban Services. The ACT Government has made the decision that the site will be sold for Aged Persons Accommodation that may include **Supportive Housing** (see definitions). We have suggested that if the site is to be used for aged care, then it would be appropriate that the highest need for a nursing home should be met before the site is used for independent living units.

It is also the view of our Association that if it eventuates that the site is not suitable for a nursing home (perhaps with a small number of aged person's independent living units to give financial support to the Nursing Home), then it should be retained as a "Community Facility" site and the community should be further consulted on other appropriate community uses for the site. The "Community Facility" land use policy in the *Territory Plan* allows for a wide range of land uses including:

- Business agency (not for profit),
- Child Care Centre,
- Community Activity Centre,
- Community Theatre,
- Cultural Facility,
- Educational Establishment,
- Health Facility, Hospital,
- Indoor Recreation Facility,
- Office (not for profit),
- Outdoor Recreation Facility,
- Parkland,
- Place of Worship, Religious Associated Use,
- Public Agency (not for profit),
- Residential Care Accommodation (see definitions),

• Supportive Housing (see definitions).

#### **Definitions** (from the *Territory Plan*):

**Residential Care Accommodation** means the use of land by an agency or organisation that exists for the purposes of providing accommodation and services such as the provision of meals; domestic services and personal care for persons requiring support. Although services must be delivered on site, management and preparation may be carried out on site or elsewhere. Common Terminology: nursing home, hospice, special care establishment, special care hostel, supported dwelling, special dwelling, convalescent home, retirement complex.

Supportive Housing means the use of land for residential accommodation for persons in need of support, which is managed by a Territory approved organisation that provides a range of support services such as counselling, domestic assistance and personal care for residents as required. Although such services must be able to be delivered on site, management and preparation may be carried out on site or elsewhere. Housing may be provided in the form of self contained dwellings. Common Terminology: aged persons units, community housing, older persons units, rooming house, university college.

## Griffith Library – Will it be kept?

The Griffith Neighbourhood Plan has established that the current Griffith Library site is to be retained as a community facility but is not specific as to what this may include. The Neighbourhood Plan also suggests that the Library may move to a new site closer to the shops.

Our Association has suggested that the Library buildings should be used for a mixed-use Community Centre which includes the Griffith Library. We fear that if the Library moves, then we may lose it altogether.

# • A10 "Residential Core Areas" – Will this higher density housing damage the character of our older suburbs?

This remains a contentious issue. Despite overwhelming community opposition to more A10 areas in our suburbs, the ACT Government is still adamant that it will happen. Do you support our Association going forward with nominating the older parts of our suburbs to the Heritage Register to protect them from A10?

## • Throsby Park – Will the ACT Government retain all of the open space and especially the playground and the many mature trees?

Only part of Throsby Park is currently zoned as "Urban Open Space Land" under the *Territory Plan*. The remainder is zoned as "Restricted Access Recreation Land" (the site of the old tennis courts) and "Community Facility Land" (the site of the playground and the large trees near the car park).
